APPLICATION – ADMISSION PROCEDURES

Valley Christian School purposes to disciple young people for Christ. We desire to take Christian children and assist the family and the church in bringing them up in the nurture and admonition of the Lord. To this end, Valley Christian School seeks to enroll students who are interested in Christian living and academic achievement.

The following steps are required for admission to Valley Christian School:

- Forms & Fees. This student application form must be completed and returned to the school together with the registration form and fees. General tuition is pro-rated by the week and will be refunded on that same basis upon early withdrawal with the following exception: no tuition will be refunded if withdrawal takes place after March 31st. Also, there is no refund of registration fees, technology fees or of junior high or high school additional tuition for early withdrawal. All but \$25.00 of the registration fee is returned (upon request) if an applicant is refused admittance or is admitted and then withdraws prior to the student(s) attending class.
- 2. **Parent Orientation.** The Parent Orientation session is a 45 minute session designed for parents only. Its purpose is to acquaint you with our commitment to Godly Parenting (Christian Education).
- 3. Interview. An interview with the admission committee representative (generally a board member). This session must include both parents and the child or children seeking admission. The main emphasis is on each person's personal walk with the Lord.

Note: The Valley Christian School Board of Trustees makes all final decisions on admissions.
