**Enrollment Fees:** Grades Pre-K – 12<sup>th</sup> \$100.00 per student

Enrollment fees are required of all students annually and must be paid in full prior to the first day of school.

**Technology Fee: Pre-K – 12<sup>th</sup>** \$25.00 per student

To cover additional costs for technology, this fee will be added to each family's general tuition for each student in these grades. This fee is not pro-rated for late enrollment or for early withdrawals.

Class Fee:Junior High (7-8)\$300.00High School (9-12)\$500.00To cover additional program costs, this fee will be added to each family's general tuition for each student in these grades. This<br/>fee is not pro-rated for late enrollment or for early withdrawals.

Sports Fees:Junior High (7–8)\$50.00 per sportHigh School (9–12)\$75 per sport / \$150 for FootballSports fees are due before the first day of practice for that sport.This fee is not pro-rated for late entries or withdrawals.

**Returning Student Credit:** \$100.00 credit per returning student who meets the following requirements: Students in grades  $Pre-K - 12^{th}$  who remain enrolled for the next school year will be granted a tuition credit of \$100 if the following requirements are met: A.) at least one parent attends our annual Faith Challenge Celebration, B.) enrollment fees for the upcoming year are paid by designated deadlines (1-3 installments), and C.) family tuition account is current as of June  $20^{th}$ . There is no tuition credit for new students who did not attend VCS the preceding year.

Tuition Payment Plans: All family tuition must be paid in one of two ways:

**Plan 1**: Single payment for a 2% tuition discount, if paid in full by 8/1 of before the 1<sup>st</sup> day of attendance for late enrollees. **Plan 2**: Monthly payments made through the FACTS automated bank withdrawal program. Parents may choose to have withdrawals made on either the 5<sup>th</sup> or 20<sup>th</sup> of the month over a 10- or 12-month period, to be paid in full by June 20<sup>th</sup>.

**Refunds:** General tuition is pro-rated by the week and will be refunded on that same basis upon early withdrawal with the following exception: no tuition will be refunded if withdrawal takes place after March 31<sup>st</sup>. There is no refund of enrollment fees, technology fees, class fees, or sports fees for early withdrawal or cancelled enrollment. All but \$25.00 of the enrollment fee is returned if an applicant is refused admittance.

**Tuition Assistance:** To apply for needs-based tuition assistance you must apply through FACTS online at www.factstuitionaid.com. Once you have submitted your application to FACTS and we have received the assessment and assistance recommendation from them, we will review the FACTS assessment and make a determination based upon the amount qualified for and the amount of financial assistance resources available. There is no guarantee that every qualified applicant will receive tuition assistance. Financial assistance is awarded in April and May. The deadline for returning families to apply online is March 31<sup>st</sup> for April awards and May 1<sup>st</sup> for May awards.
